Consignment Agreement

Consignment Period

The consignment period shall be _____ commencing from the date of this Agreement, unless otherwise agreed upon by both Parties in writing.

Pricing and Sale

- The Consignor shall have the right to determine the sale price of the Goods in consultation with the Consignee.
- The Consignor will remit to the Consignee _____ of the final sale price.
- The Consignor shall provide the Consignee with a detailed sales report on a monthly basis, and mail a check out for the total due to the consignee by the **10th of each month.**

Obligations

- a) The Consignee represents and warrants that they have legal ownership of the Goods and have full authority to consign them.
- b) The Consignor shall exercise reasonable care to protect and maintain the Goods in good condition throughout the consignment period.
- c) The Consignee acknowledges that the Consignor is not responsible for any loss, damage, or theft of the Goods, unless due to its own negligence or willful misconduct.

Termination

- a) Either Party may terminate this Agreement by providing written notice to the other Party.
- b) In the event of termination, all unsold Goods shall be returned to the Consignee within 30 days.

Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Washington State, without regard to its conflict of laws principles.

Entire Agreement

This Agreement constitutes the entire understanding between the Parties and supersedes all prior discussions, negotiations, and agreements, whether oral or written, relating to the subject matter hereof.

Amendments

No modification or amendment to this Agreement shall be valid unless made in writing and signed by both Parties.
